## Facts & Figures

### Pro-Israel PACs Predominate

Pro-Israel PACs—Political Action Committees—outnumber and outspend their pro-Arab counterparts, according to a recent MIDEAST OBSERVER study of Federal Election Commission (FEC) data.

33 pro-Israel PACs contributed more than \$1.8 million to 268 different election campaigns during the 1981-82 FEC reporting cycle.

On the other side, the pro-Arab PACs are in their earliest stages of development. The MIDEAST OBSERVER found only two pro-Arab PACs: Americans for Lebanon Political Action Committee (ALPAC) and Middle East PAC (M-PAC).

ALPAC is more closely associated with the political views of ALL (the American Lebanese League) than with NAAA (the National Association of Arab Americans). ALPAC contributed a total of \$5,500 to six candidates in the 1982 election. It gave \$1,000 each to the campaigns of Senators Mitchell (D-ME) and Wilson (R-CA) and to Representatives Hamilton (D-IN), Hiler (R-IN), and Kazen (D-TX). Also, it gave \$500 to the unsuccessful effort of Richard Anter, an Ohio Republican, to gain the seat eventually held by Ed Feighan (D-OH).

M-PAC is only newly formed. It is headed by James Zogby, Executive Director of the American-Arab Anti-Discrimination Committee (ADC). Zogby told the MIDEAST OBSERVER, and FEC records confirmed, that there has been "zero money in; and zero out."

To date, that is the extent of the pro-Arab, single issue PACs. As Ed Roeder, editor of the authoritative "PACs Americana", told the MIDEAST OBSERVER early in this study as

we sought for pro-Arab PACs: "There's no balance on this one."

The 20 senatorial candidates actually elected in 1982 that received more than \$10,000 from pro-Israel PACs are, along with their dollar amounts:

Many more Democrats than Republicans enjoyed the support of the pro-Israel PACs. For example, all 16 House candidates receiving more than \$10,000 each from these PACs were Democrats, and less than one-third (nearly one-quarter) of the 215 House candidates supported by these PACs were Republicans.

On the Senate side, only six Republicans were among the 26 senatorial candidates who got more than \$10,000 each.

A large amount of money—\$232,600 altogether—went to five incumbents on the Senate Appropriations Committee. The five: Sasser (D-TN), Byrd (D-WV), Burdick (D-ND), DeConcini (D-AZ), and Weicker (R-CT).

The biggest single recipient of pro-Israel PAC money was Richard Durbin (D-IL). He received \$103,325 from 31 of the 33 pro-Israel PACs (see the listing of them on page 2). Durbin defeated Republican Paul Findley who held the ranking minority position on the House Mideast panel.

The eleven Representatives elected in 1982 with pro-Israel PAC receipts of more than \$10,000 were:

Of the 10-member House Mideast panel, only three of its current members received more than a total of \$300 from the pro-Israel PACs. The three: Tom Lantos (D-CA) with \$15,550; Larry Smith (D-FL) with \$2,750; and Andy Ireland (D-FL) with \$1,000.

## News Briefs

### O'NEILL'S MIDEAST PANEL

During the debate on whether or not to authorize U.S. forces in Lebanon, House Speaker Tip O'Neill promised to monitor personally the situation in Lebanon. To that end, he has set up the "Speaker's Ad Hoc Lebanon Monitoring Group."

The Group's members, all Democrats, are: O'Neill(MA), Wright (TX), Foley (WA), Alexander (AR), Zablocki (WI), Williams (MT), Mikulski (MD), Gejdenson (CT), Bonior (MI), Rahall (WV), Hawkins (D-CA), Smith (FL), Matsui (CA), Hamilton (IN) and Murtha (PA).

In its first meeting on October 24, the committee met for two hours in a closed door session with Secretary of State Shultz and Defense Secretary Weinberger.

During that session, O'Neill reports that the Committee firstly expressed its "overwhelming concern" for the safety and security of U.S. troops in Beirut. Secondly, the O'Neill-led group urged the Administration to greatly accelerate and expand its diplomatic initiatives to get

foreign troops out of Lebanon and to create a government of national reconciliation. And, finally, "the committee," according to O'Neill, "strongly urged that a highly respected and experienced individual be named to replace Ambassador Robert McFarlane" as Mideast peace negotiator.

### MURPHY TAKES TOP STATE SPOT

Richard W. Murphy succeeds Nicholas Veliotis as Assistant Secretary of State for Near Eastern and South Asian Affairs—the State Department's top Mideast post.

When first appointed there was some initial opposition in Congress because Murphy, an "Arabist", has extensive experience in the Arab world but not in Israel. He has served in posts in Syria and Jordan and held Ambassadorships in three Arab countries—Syria, Mauritania and Saudi Arabia.

Murphy, however, disarmed his opponents with successful diplomacy. Prior to his Senate Foreign Relations Committee confirmation hearing on October 18, Murphy visited Israel and also made the rounds visiting various Senators. Apparently, he won

them over. Senator Rudy Boschwitz (R-MN), chairing the hearing, praised Murphy's "formidable" qualifications, saying that he "comes with a broader background than anyone else" who has appeared before Boschwitz for confirmation to a Mideast post.

Senator Pressler (R-SD), arriving near the end of the hearing, raised the one question about Arabists and their reputed favoritism toward the Arabs.

Murphy's reply: "...to label a whole class of foreign service officers as pro-one-side or the other because of their service in that area... I think is most unfair. I notice you don't hear it said about our officers that spend an equal amount of time studying Russian. We don't assume that they are automatically Communist sympathisers. And I hope that the perversion of the word "Arabists" in the American vocabulary will begin to disappear."

While substantively U.S. Mideast policy is unlikely to change due to Murphy's appointment, the effectiveness of U.S. diplomacy may be enhanced.

Publications**Recent Publications Available**

The following publications are now available from either the Senate Foreign Relations Committee (S) or the House Foreign Affairs Committee (H): "MARKUP: WAR POWERS RESOLUTION" 76 pages of the Senate Foreign Relations Committee markup of joint resolutions relating to Lebanon and the War Powers Resolution. The hearing was on September 23, 1983 (S).

"WAR POWERS RESOLUTION" 39 pages of the September 21, 1983, hearing that preceded the markup described above. (S)

"SECURITY AND DEVELOPMENT ASSISTANCE," 708 pages of hearings in February and March of 1983 before the Senate Foreign Relations Committee on FY 1984 foreign aid. Pages 279-417 are of the March 2 hearing on the Middle East portion of the aid program. (S)

"THE U.S. EMBASSY BOMBING IN BEIRUT" 25 pages of a June 28, 1983, hearing before the Subcommittees on International Operations and on Europe and the Middle East of the House Foreign Affairs Committee. Witnesses included Undersecretary of State Lawrence Eagleburger and the then-Ambassador to Lebanon Robert Dillon. (H)

"DEVELOPMENTS IN THE MIDDLE EAST, JUNE 1983," 70 pages of a June 2, 1983, hearing before the House Foreign Affairs

Committee's Subcommittee on Europe and the Middle East. The testimony was provided by Nicholas Veliotes of the State Department and Gerald Kamens of the Agency for International Development. Responding to Subcommittee Chairman Lee Hamilton's request for a copy of the May 17, 1983, Agreement between Israel and Lebanon, the State Department supplied a copy of the English version of that Agreement for inclusion in the appendix of this print. (H)

"U.S. INTERESTS IN THE EASTERN MEDITERRANEAN: TURKEY, GREECE, AND CYPRUS," 40 pages, a report dated June 13, 1983, prepared for the House Europe and Middle East Subcommittee by the Library of Congress' Congressional Research Service. After listing a series of possible "urgent and unsettling" challenges that might occur in the area, the CRS report notes that these circumstances might cause the U.S. to "consider a more activist approach to the region. (H)

"EXECUTIVE-LEGISLATIVE CONSULTATION ON U.S. ARMS SALES," No. 7 in a series on Congress and Foreign Policy. The 39 page House Foreign Affairs Committee print was prepared by the Congressional Research Service. In discussing specific arms sale cases, all

of the examples are of sales to the Middle East. These include: AWACS to Iran and to Saudi Arabia; the 1978 package of planes for Israel, Egypt and Saudi Arabia; an air defense system for Jordan; and air-to-air missiles for Saudi Arabia. (H)

"UNITED STATES POLICY TOWARD LEBANON—RELIEF AND REHABILITATION ASSISTANCE," 333 pages of hearings and a markup of H.R. 6631, a bill providing emergency relief monies for Lebanon in the aftermath of Israel's June 1982 invasion of Lebanon. The material includes public, Administration, and Congressional witnesses testifying on the effects of the Israeli invasion on Lebanon. The hearing dates: June 17, 22; July 13 and 15, 1982. (H)
